PIMCO Funds BROKER DEALER BACK OFFICE USE ONLY

The PIMCO Fund listed below will liquidate on January 31, 2018. Please refer to the following timeline for key dates and ensure this information is provided to all interested parties within your firm.

Effective November 20, 2017: Upfront commissions and CDSCs will be waived through liquidation date. Trail payments
accrue immediately for C shares purchased through fund closing. Shares of a liquidating class C fund may be exchanged
to the corresponding class A fund at NAV.

Please see the sections entitled **Waiver of Contingent Deferred Sales Charges** and **Sales at Net Asset Value** in the SAI, located on <u>www.pimco.com</u> under Resources -> Fund Literature.

- December 29, 2017: Last day for purchases and exchanges purchases into Funds.
- January 24, 2018: Settlement for the Funds will change to T+1.
- January 30, 2018: Last day to redeem (including exchange redemptions) direct or via NSCC for all share classes. DCC&S redemptions and exchange redemptions will be accepted on the morning of January 31 for trade date January 30.
- January 31, 2018: No trades will be accepted for this date. The Funds will strike a four digit final NAV and all accounts
 remaining in the Funds will be liquidated and proceeds sent accordingly. This will be reported as a taxable event where
 applicable.
- Pending: Distributions are under assessment. If an additional distribution will be paid, an update to this announcement will be sent.
