Effective at the close of business March 22, 2019, the American Century® International Discovery Fund will merge into the American Century® International Opportunities Fund.

The decision to merge these funds is based on the similarity in philosophy, investment objectives and an opportunity to consolidate our current lineup. An added benefit is a resulting lower management fee for shareholders of both funds. The merger will be a non-taxable event for shareholders.

December 4	Prospectus supplement sent to existing shareholders
March 19	After the close of business, no purchases will be accepted (except reinvested dividends and capital gain distributions). New accounts established by registration transfer into the closed fund(s) will be permitted.
March 19	Any required income distributions will be paid
March 21	Final trade date for processing redemptions and exchanges through the NSCC.
March 22	Final Trade Date for processing manual redemptions and exchanges. NAV price for merger will be two decimals. Merger ratios, rounded to nine decimals, available Friday evening.
March 23	Networking Activity Records (F55) generated and sent with a transaction type of W0 (Fund Merger Non-Taxable)
