

Important Changes to CUSIP #'s - Effective on or about June 3, 2019



Effective on or about June 3, 2019, the Dreyfus U.S. Retail business and its long-term mutual funds will be renamed “BNY Mellon” to align with the BNY Mellon Investment Management brand. As part of this initiative, The Dreyfus Corporation (the investment adviser for the Dreyfus Family of Funds) will be renamed BNY Mellon Investment Adviser, Inc.; MBSC Securities Corporation (the distributor of Dreyfus open-end funds) will be renamed BNY Mellon Securities Corporation; and the Dreyfus Family of Funds will be renamed the BNY Mellon Family of Funds.
