Fund Liquidations | JPMorgan International Equity Funds

Effective on or about **October 13, 2017**, the **JPMorgan International Opportunities Fund** and **JPMorgan Latin America Fund**, and on or about **October 20, 2017**, the **JPMorgan China Region Fund**, **JPMorgan Emerging Markets Equity Income Fund** and **JPMorgan International Discovery Fund** and will be liquidating.

As a result of these upcoming liquidations, the following changes will be occurring:

Effective **August 24, 2017**:

- No new initial purchases will be accepted.
- Existing shareholders of record may continue to make additional purchases of fund shares up to and including **October 6, 2017** for the **JPMorgan International Opportunities Fund**, and **JPMorgan Latin America Fund**.
- Existing shareholders of record may continue to make additional purchases of fund shares up to and including **October 13, 2017** for the **JPMorgan China Region Fund**, **JPMorgan Emerging Markets Equity Income Fund** and **JPMorgan International Discovery Fund**.
