Effective May 1, 2017 for the LoCorr Investment Trust the following changes will be made:

• **Fund Name Changes:**

• **Short-term redemption fees:**

The Macro Strategies (formerly known as the Managed Futures) Fund, Long/Short Commodities Strategy Fund, Dynamic Equity (formerly known as the Long/Short Equity) Fund, Market Trend Fund and Multi-Strategy Fund will no longer impose a 1% redemption fee for shares redeemed within 30 days of purchase. (See tickers and cusips below)

This change does NOT affect the Spectrum Income Fund which will continue to impose a short-term redemption fee of 2% for shares redeemed within 60 days of purchase.

• **Rights of accumulation:**

All LoCorr Funds will include Class C share balances when calculating the breakpoints for Class A shares subscriptions via the Funds' rights of accumulation provision.

All of the LoCorr Investment Trust are distributed and underwritten by Quasar Distributors, LLC.
