As part of our ongoing commitment to keep you informed about our product line-up, included below are updates to existing products offered by Legg Mason.

ClearBridge Global Growth Trust – Name, Strategy, Benchmark, Portfolio Manager and Related Changes

The Fund's Board of Trustees has approved certain changes to the ClearBridge Global Growth Trust whose strategy will change from a "global growth" strategy to an "international growth" strategy. This change will leverage existing ClearBridge capabilities with respect to its international growth strategy. Effective December 31, 2015, after a 60 day notice period to shareholders, the Fund's name, investment strategy, performance benchmark and other related changes will occur. Additionally, effective October 16, 2015 Michael Testorf, CFA will co-manage the Fund with Elisa Mazen.

Certain Legg Mason Funds - Conversion of Class B Shares to Class A Shares

Effective July 1, 2011, Legg Mason closed Class B shares to purchases for new and existing investors. Class B shares are currently available for incoming exchanges and dividend reinvestments. The share classes are reviewed periodically to assess ongoing viability and to attempt to protect shareholders from rising costs that may be associated with a declining asset base. Effective on or about close of business December 15, 2015, Legg Mason has determined to accelerate the conversion of Class B shares to Class A shares for all shareholders for the following funds:

ClearBridge Large Cap Growth Class B Western Asset New Jersey Municipals Fund Class B Western Asset Short Duration High Income Fund Class B

Timeline:

On or about close of business December 11: Close Class B shares of impacted funds to incoming exchanges and dividend reinvestments

On or about close of business December 15: Convert Class B shares of impacted funds to Class A shares
