Effective on or about **July 2, 2018** MFS Fund Distributors, Inc. will be reopening the MFS U.S. Government Cash Reserve Fund to new investors. Interest rates have risen such that the Fund is now producing a positive yield for investors. The MFS U.S. Government Cash Reserve Fund has been closed to new investments, with the exception of dividend reinvestments and exchanges from another MFS Fund, since February 27, 2009. There will be no changes to the investment strategy of this fund as a result of the change.

Effective on or about **August 15, 2018**, the MFS Commodity Strategy Fund will open to general retail investment. Since its inception in 2010 the MFS Commodity Strategy Fund has been used as an underlying investment for the MFS Asset Allocations Funds and the MFS Lifetime Funds.

MFS believes commodity investing may offer investors an opportunity to complement traditional equity and fixed income investing. The funds' objective is to seek total return. The fund will offer Class A, B, C, I, R1, R2, R3, R4 and R6 shares. There will be no changes to the investment strategy of this fund as a result of the change.
