**RE: Oppenheimer Rochester® Minnesota Municipal Fund Reminder**

Dear Business Partners:

As noted in our previous memos, the following changes to Oppenheimer Rochester® Minnesota Municipal Fund (“the Fund”) will be effective as of the start of business on **October 15, 2018**:

- The Fund will transition from a Minnesota municipal bond fund to a national municipal bond fund.
- The Fund will be renamed Oppenheimer Municipal Fund.
- The Supplement dated July 27, 2018, to the Prospectus and Statement of Additional Information (“SAI”) regarding the Fund’s closure to new investors will be superseded and no longer be in effect. The Fund will accept purchase orders from new investors, and shareholders of other Oppenheimer funds will be able to exchange shares of other funds into the Fund, subject to the provisions of the Prospectus and SAI.
