

**PRUDENTIAL INVESTMENTS UPDATE****QMA NAME ADDED TO PRUDENTIAL FUNDS****DECEMBER 2015**

The Board of Directors recently approved adding “QMA” to the name of Prudential retail mutual funds for which Quantitative Management Associates (“QMA”) is the sole sub-adviser. This change will be effective on or about December 30, 2015.

Adding “QMA” to the fund names will help increase awareness of the distinct expertise QMA brings to the products it manages, and will also help investors to easily identify the sub-adviser for the funds.

Since 1975, QMA has developed and applied an innovative, research-driven process that enables it to identify alpha opportunities across the equity universe. This approach has led to enhanced risk-adjusted performance for a wide range of traditional and alternative investment strategies.

The following Prudential funds are affected by the name change. The name changes will be initially reflected in a supplement to the registration statement for each impacted fund, which will be filed on December 10, 2015, and will then be rolled into the annual update to each impacted fund’s registration statement, starting with the funds having a 10/31 fiscal year end.

Please note that none of the existing tickers or cusip numbers for the impacted funds will be changing.
