IMPORTANT NOTICE - PLAN OF REORGANIZATION

Acquisition of certain Sentinel Funds by Touchstone Investments

The proposed plan of reorganization of certain Sentinel Funds into Touchstone Funds has been approved by Sentinel shareholders. A total of 34 existing Sentinel CUSIPS (9 Mutual Funds and 4 Variable products) are reorganizing into 10 existing Touchstone CUSIPS and 19 new Touchstone CUSIPS. In addition, 2 new Touchstone CUSIPS will be launched. The complete list of CUSIPS from Sentinel to Touchstone is provided on the last two pages of this communication.

The merger activity will take place at the close of business on Friday, October 27, 2017.

NSCC Conversion Type: DTCC Networking Cutover from Sentinel participant #5873 (Alpha Code ES) to Touchstone participant #5711 (Alpha Code WG)

Please see the below trading timeline and other important information regarding this transition:

Trade Date Monday, 10/23 (Pre-Conversion):

- All impacted NSCC-eligible Sentinel Funds will begin T + 1 settlement

Wednesday and Thursday – 10/25 is Record/Ex date and 10/26 is Payable date (Pre-Conversion):

- An income distribution/and or capital gain may be paid prior to the reorganization for the 5 Sentinel Funds which are merging into existing Touchstone Funds: **Sentinel Government Securities Fund, Sentinel Low Duration Bond Fund, Sentinel Multi-Asset Income Fund, Sentinel Sustainable Core Opportunities Fund, and the Sentinel Total Return Bond Fund.**

Thursday, 10/26 (Pre-Conversion)

- Networking transactions for trade date Thursday 10/26 will be accepted and processed. (This is standard processing.)
- Standard trade edits will apply and trades that cannot be accepted for any reason will be rejected. Communication with the impacted firms will be completed by BFDS to ensure processing can be completed.

Friday, 10/27 (Pre-Conversion)

- DCC&S and Late Order trades for trade date Thursday 10/26 received for NSCC Participant # 5873 will confirm and settle same day.
- Networking transactions for Friday 10/27 will be accepted and processed. This is standard processing.
- NSCC trading will be suspended for trade date Friday 10/27. Any trade placed for trade date 10/27 for NSCC Participant #5873 will be rejected for 177-Transaction Not Allowed Against Fund.

Monday, 10/30 (Post-Conversion)

- BNY Mellon Asset Servicing will send out the F55 Activity File Merger Activity W0 records.
- All Funds will revert back to T + 2 settlements.
- There will be a merger ratio for the CUSIPs that are merging into existing Touchstone Funds. If you would like to receive the merger ratios, please contact BNY Mellon Dealer Services at 877-332-2371.
- NSCC trading activity will be accepted for NSCC Participant #5711 for trade date Friday, 10/27 for the former Sentinel Funds, but must be submitted in the new CUSIPs.
- Firms are asked to contact BNY Mellon Asset Servicing at 877-332-2371 for price protection on any rejected orders for impacted Sentinel Funds for trade date Friday 10/27.
- Please note that Touchstones' cutoff time for estimates is 8:30am EST
- Intermediaries can no longer trade using the Sentinel CUSIPs.

Merger Processing

- The merger will be processed as a non-taxable event.
- The merger will be processed using a 4 decimal NAV. This extended NAV will be for all transactions, including the merger transactions on both the 'from' and 'to' sides for Friday 10/27.
- Some account numbers, as part of the merger may be reassigned. Changes to networked accounts and trust networked accounts will be communicated directly by the BNY Mellon Intermediary Support Team.
- Touchstone will waive CDSC on post merger redemptions processed from acquired Sentinel accounts.
- Touchstone is not converting Letters of Intent (LOIs) and LOI balances will be forgiven (no adjustments to historical purchases).

- All outbound Networking files will remain under Touchstone Investments NSCC Participant #5711. The Touchstone Alpha Code is WG.
- BFDS/Sentinel will pay 12b-1 accruals through 10/27. BNY/Touchstone will begin 12b-1 and Shareholder Service Fee accruals effective 10/28 and they will be paid out according to the Touchstone Q4 payment schedule in January 2018.
- BFDS will perform back office support for the Sentinel Funds through Friday 10/27. For NSCC inquiries call 877-332-6207.
- BNY Mellon Asset Servicing will begin performing back office support for these Funds starting on Monday 10/30.
